申請「幼稚園入學註冊證」:(教育局資訊)

- 1. 在幼稚園教育計劃(「計劃」)下,每名 可在本港接受教育的幼兒只會獲發一張 註冊文件,而所有參加計劃的幼稚園, 只可取錄持有有效註冊文件的幼 兒。
- 2. 家長須於 2024 年 9 月至 11 月期間 為其子女向教育局申請「幼稚園入學註 冊證」(「註冊證」)。「註冊證」會於 本年 9 月開始接受申請,屆時教育局會 公布申請細則,並會在教育局網頁 (https://www.edb.gov.hk/k1-admission_tc) 上載詳情。


4. Application fee (if applicable): free

Application for the "Registration Certificate for Kindergarten Admission":

(Information from the Education Bureau)

- Under the Kindergarten (KG) Education Scheme (the Scheme), each child who can receive education in Hong Kong will only be issued a registration document and all Scheme-KGs can only admit children holding a valid registration document.
- Parents are required to submit an application for the Registration Certificate for Kindergarten Admission (RC) to the Education Bureau (EDB) from September to November 2024. The RC will be open for applications in September 2024 and EDB will announce and upload the details of application onto EDB's website

(https://www.edb.gov.hk/k1-admission_e) in due course.

如申請人在遞交申請時已提供全部所需資料及文件,教育局一般可在六至八個星期內完成審核,並以郵遞方式寄送「註冊證」給合資格接受計劃資助的申請人。如幼兒可於本港接受教育但不合乎資格接受計劃資助而未能獲發「註冊證」,教育局會為有關幼兒發出「幼稚園入學許可書」(「入學許可書」),幼兒可憑「入學許可書」註冊並入讀參加計劃的幼稚園,惟其家長須按註冊入讀之幼稚園的收費證明書繳付扣減計劃資助前的全額學費。

Upon receipt of the applications with all necessary information and documents provided, it will generally takes six to eight weeks for EDB to complete processing of the applications and issue the RC to applicants who are eligible for receiving subsidy under the Scheme by post. If a child cannot obtain an RC as he/she can receive education in Hong Kong but is not eligible for receiving subsidy under the Scheme2, EDB will then issue a Kindergarten Admission Pass (AP) to the child concerned for registration and admission to a Scheme-KG but the parents concerned are required to pay full school fees before deduction of subsidy under the Scheme as shown on the Fees Certificate of the KG to which the child is admitted.

Admission Criteria:

The child with sibling(s) currently studying in the nursery school (priority consideration subjected to the vacancies); the child from families in social need (priority consideration subjected to the vacancies). [As the number of school places is limited, please understand that NOT all applicants fulfilling the priority consideration will be guaranteed a school place.]

- 3. 以小組形式及/或個别面見

- 5. 在面見非華語幼兒時,如需要傳譯/ 翻譯服務,請致電 23615516 與本校 聯絡。本校亦接納非華語家長和幼兒 由懂中文的親友陪同會面,協助溝 通。

本幼兒學校將於 2024 年 12 月 13 日前以郵遞方式通知家長 N2(幼兒班)取錄結果。

Announcement of Admission Results:

註冊安排:

1. 正選生:

家長須於 2025 年 1 月 2 日至 4 日(統一註冊日期」)內的指定時間到本幼兒學校辦理註冊手續,並須提交「註冊證」/「入學許可書」及繳交註冊費。

2. 備取生:

本幼兒學校會發出通知(方式:電郵/ 書信/其他),請家長於指定日期到本 幼兒學校辦理註冊手續,並須提交「註 冊證」/「入學許可書」及繳交註冊費。

- 3. 家長請留意,如未能在指定的註冊日期提交「註冊證」/「入學許可書」, 本幼兒學校或未能為獲取錄幼兒完成 手續,因此家長務必於指定日期內向 教 育 局 申 請 相 關 註 冊 文 件。
- 4. 2025/26 學年的註冊費為港幣 1570 元正。如有關幼兒入讀本幼兒學校,本幼兒學校會於 9 月退回註冊費,但若家長於註冊後決定為子女轉校,請以書面通知本幼幼兒學校。本幼兒學校會盡快退回「註冊證」/「入學許可書」,但註冊費將不獲退還。在取回「註冊證」/「入學許可書」後,本幼兒學校亦不會再為該幼兒保留學位。

Registration Arrangements:

- 1. Successful applicants: Parents should complete the registration procedures for their child from 2 to 4 January 2025 (Centralised Registration Dates) by submitting the RC / AP to the KG and paying the registration fee.
- 2. Applicants on the waiting list: We will inform parents (notification means: by email/by post/others) and parents should complete the registration procedures for their child according to the specified date set by the KG. Parents are required to submit the RC / AP to the KG and pay the registration fee.
- 3. Please be reminded that if parents cannot submit the RC / AP during registration, the KG may not be able to complete registration for their child. Hence, parents are required to submit application for the registration document to EDB within the specified period.
- 4. The registration fee for 2025/26 K1 place is HK\$1570. If the child concerned studies in the KG, the registration fee paid will be refunded in September. Should parents decide to change school after registration, please notify the KG in writing. The KG will return the RC / AP as soon as possible but the registration fee will not be refunded. Upon obtaining the RC / AP, the KG will no longer keep the school place for the child.
