  - a. According to the guideline of Social Welfare Department, service unit could ask parents/guardian to pay in advance the full fee of the first month enrollment. This payment will not be refunded if parents cancel the use of service.
  - b. When submitting the registration form, please include a copy of the baby's birth certificate. If the baby has not yet been born, an application can be submitted five months before the due date at the earliest, together with a copy of the proof on mother's due date, and submitted to the day crèche supporting the document soon after the baby is born. Insufficient information will not be accepted.
  - c. According to the Privacy Ordinance, the above information is provided voluntarily and will be used for enrolment assessment as well as provision of appropriate care and arrangement for the children. Sufficient information may lead to failure to process the application. These information may be provided to concerned government departments and concerned parties whenever necessary. Under normal circumstances, the information provider could access, correct and obtain a copy of his/her given personal data.

The information provided above is correct. If any of the above-mentioned information is falsely reported, your society has the authority to reject my child's application for enrollment.
